## **GENERAL GUIDELINES**

**1.(A)** Age limit should not exceed 30 years for the post at Sr No. 01 age is relaxable for Govt. servants/ST/OBC/SC/EWC as per the instruction or orders issued by the Government from time to time.

**1.(B)** Age limit should not exceed 45 years for the mentioned posts from sr.no 02 to 07 as on date of advertisement age is relaxable for Govt. servants/ST/OBC/SC/EWC as per the instruction or orders issued by the Government from time to time.

2.All applicants must have knowledge of **English, Hindi, Konkani, and Marathi.**

3.Candidates applying for the post must submit the application in the prescribed format along with self-attested copies of the following documents:

1. Birth Certificate
2. Educational Qualification Certificates
3. Experience Certificates
4. Valid Employment Registration Card
5. 15 Years Residence Certificate in Goa issued by the Competent Authority
6. Valid Category Certificate issued by the Competent Authority (if applicable)
7. One recent Passport size photograph affixed on the application form

**4.The Application form will be available at KTCL Head Office between 10.30 a.m. to 05.00 p.m. (lunch break 1:00 p.m. to 02:00 p.m) on payment of Rs.100/- for Unreserved category and Rs. 50/- for Reserved category.**

5. The generated hard copy of Application Form filled in with necessary details along with the documents and affixed with his/her recent self-attested passport size photograph on the space provided and duly signed at the bottom of the Application form shall be submitted by hand delivery/postal delivery in the **Parasio De Goa, Alto Porvorim, Bardez – Goa Pin Code – 403521 from 14/11/2025 to 28/11/2025 between 10.30 a.m. to 05.30 p.m. (lunch break 1:15 p.m. to 02:00 p.m.) the hard copy of the application form received after the due date will be summarily rejected.**

6. Only the eligible candidates fulfilling the criteria's as per recruitment rules/advertisement shall apply. However, the candidature of shortlisted candidates shall not be considered, if he/she is found ineligible at the time of verification of essential documents, even though he/she has passed the examination.

7. Only application will be accepted with declaration from candidates stating that "the contents of the applications are true to his/her own knowledge and he/she process the requisite qualification and other mandatory documents for the posts. He/She understand that in the event of particulars or information given. herein being found false or incorrect, his/her candidature for the recruitment is liable to be **"Rejected or Cancelled Even After Selection"**.

8. There will be written examination/trade test will be taken wherever applicable. Only qualified candidates shall be called for written examination and trade test.

9. The post at Sr. No.01 will have 100 marks written examination and posts from Sr. no 02 to 07 shall be 50 for written examination and 50 for trade test.

10. Selection of the candidates shall be determine in accordance with the total marks obtain by each candidates in written examination and trade test wherever applicable. The entire result shall be published on the notice board of the department as well as on the Department portal [ktclgoa.com](http://ktclgoa.com) and [www.goa.gov.in](http://www.goa.gov.in)

11.If two or more candidates secure equal marks in the written examination than order or merit shall be as per their date of birth and if incase the date of birth is also same, then the candidate possessing higher educational qualification will be placed higher in the merit list.

12. There shall be no allocation of marks for educational qualifications and selection of the candidates shall be done strictly as per the marks scored in the written, trade test or both.
13. The candidates already working in the Government, Local Self Government, Semi Government autonomous bodies or establishment or any other department establishment or institution being an instrument of the Government should send their application through proper channel only.
14. The crucial date for determining the eligibility as to the educational qualification, age, valid domicile/residence certificate, valid employment card, caste certificate, etc. shall be **28/11/2025** (closing date) for appointment to the above posts.
15. Interested candidates should ensure that they are fulfilling the educational qualification/criteria prescribed for the above posts with the valid certificate of qualification, computer literacy certificate, experience certificate, 15 years and Birth Certificate Caste
16. No TA/DA will be paid either for appearing for written examination, trade test or joining the posts.
17. A separate application should be submitted for each category of posts.
18. The vacancies at Sr.no. 01 are likely to increase and will be filled from the merit list taking into consideration as per reservation roster in reserved categories.
