3. Selected candidates have to submit the “Police Verification Certificate” after joining.
4. Verification of credentials shall be done for selected candidates prior to **creation of contract**. In case of any deviation or non-conformity with the desired qualification, candidature of the candidate shall be summarily rejected.
5. **No TA/DA will be paid to the applicants called for at any stage of the selection process.**
6. The Selected candidates must execute a Contract for a period of **12 months** of training as per provisions of the Apprentices Act, 1961 and rules framed there under.
